DIRECTIONS FOR USE

BRANDT A+ is a proprietary non-ionic surfactant containing unique drift reduction technology. BRANDT A+ reduces physical drift and enhances deposition and surface activity properties to provide superior wetting, uptake, and retention of many agrochemical sprays. BRANDT A+ may be used on agricultural, aquatic, forestry, turf and ornamental, and non-cropland sites. NOT FOR AQUATIC USE IN WASHINGTON.

Read and follow the precautions, restrictions and recommendations on the labels of pesticides used with BRANDT A+. Use according to the most restrictive label directions for each product in any tank mix.

COMPATIBILITY: BRANDT A+ is compatible with most pesticides. However, if the desired combination has not been previously used, a compatibility test is recommended.

MIXING: Fill spray tank 1/2 full of water and begin agitation. Add pesticides as directed by label or in the following sequence and continue filling tank: (1) Dry flowables or water dispersing granules, (2) Wettable powders, (3) Flowables, (4) Solutions, (5) Emulsifiable concentrates. Continue agitation until spray solution is completely mixed. Add the recommended amount of BRANDT A+. Continuous agitation of finished spray is recommended. If spray solution has been allowed to stand, thoroughly agitate and remix before application.

RECOMMENDATIONS: Specific use rates will vary with conditions of application such as water hardness, application method, equipment, spray droplet size, spray nozzle selection, or condition or size of foliage. Also, higher rates than those below may be used if recommended by pesticide labeling. Follow pesticide label directions. However, do not add this product at a rate which exceeds 5% of the finished spray volume.

GROUND: (10 to 300 GPA spray volume):

Use BRANDT A+ at the rate of 4-32 fluid ounces per 100 gallons of spray solution when used as a non-ionic surfactant/penetrant. Use 1-2 pints per acre when used as a replacement for crop oil concentrate or methylated seed oil adjuvants.

AERIAL: (or with spray volumes under 10 GPA):

Use BRANDT A+ at the rate of 2-8 fluid ounces per acre.

DRIFT REDUCTION:

Use BRANDT A+ at the rate of 2-3 pints per 100 gallons of spray solution.
